



GUIDELINES FOR FLYERS & BROCHURES FOR CME ACCREDITED ACTIVITIES

The following elements should be included in a flyer, brochure or announcement of a CME accredited activity:

- Organization or department name
- Title, date, time, location
- Overview (brief description)
- Speaker(s), Planners, Activity Director (or link to list)
- Target audience
- Objectives
- Disclosure of planners, speakers, commercial support (grant)
- Accreditation statement
- WebEx link for live stream (if applicable); Bit.ly recommended
- Contact and registration information (including link to online registration)

EXAMPLES

Disclosures and Accreditation Statements should be in the same size font as the text of the flyer or brochure (they can be in a different font) but no smaller than 10 points.

Accreditation Statements
