□ Craig and Karen Barnhart Accounting Scholarship — Undergraduate, Accounting major, minimum GPA of 3.0.
□ <b>James O. Beard, Jr. Scholarship</b> – Undergraduate, junior or higher status, Accounting major, minimum GPA of 3.0. Preference given to an active member of an accounting-related RSO.
□ Bohannon Family Endowed Scholarship – Undergraduate, CBA admitted, Accounting major, 3.0 overall, 3.20 Accounting. Need-based Scholarship.
□ <b>Deloitte LLP Award</b> – Student must be enrolled in the CBA, majoring in accounting, with a minimum GPA of 3.3.
□ <b>Robin Dilling Vatalaro Scholarship</b> – Student must be a senior majoring in accounting, who has a minimum GPA of 3.00.
□ <b>Financial Executives Int'l Western Michigan Chapter Scholarship</b> — Student must be a junior or senior majoring in accounting, who has a minimum GPA of 3.25 overall and 3.50 in their major. Full-time student who is heavily involved in extracurricular activities such as accounting or finance clubs (e.g. Beta Alpha Psi), and/or raising a family, involved in athletics, or working an outside job while in school. Recipients are requested to attend a FEI-WM chapter dinner meeting for an opportunity to network with financial executives and be recognized for their achievement.
□ <b>Jakolat Family Endowed Scholarship</b> – Established in 2017 for an accounting major in their junior or senior year with a minimum 3.00 GPA. Preferences are as follows, first preference for a student who graduated from Alma High School, Alma, Michigan, second preference for a student who graduated from a high school within Gratiot County, Michigan, third preference for a student who graduated from a high school within Kent County, Michigan.
□ <b>Philip Kintzele Accounting MBA Scholarship</b> – Established in 1986. Recipient must be an accounting major having completed 100 credit hours towards completing their bachelor's degree who has a minimum GPA of 3.70. Recipient must be pursuing the Accelerated MBA Accounting program, entering the program in forthcoming summer or fall semester. Recipient must be attending classes at the main campus in Mt. Pleasant, Michigan.
□ Masters of Business Administration/Accounting Scholarship − CMU Accounting BSBA Graduate completing MBA, 3.4 undergraduate GPA, 550 GMAT, cannot receive a Graduate Assistant position.
□ <b>Maner, Costerisan &amp; Ellis, P. C. Scholarship</b> – Minimum 3.3 GPA. Student must be planning to major in accounting. Resident of Clinton, Eaton, or Ingham County.
☐ Linda Jaye Masak Memorial Scholarship — 3.7 GPA Overall and 3.7 GPA Accounting.
□ <b>Doeren Mayhew Scholarship</b> – Undergraduate accounting students enrolled in the College of Business Administration; preference for distribution is for the funds to be given to two juniors and three sophomores. The recipient will be performing at a high level in their academic coursework (at least a 3.5 overall GPA), in particular their accounting coursework. Selection will be based upon overall GPA, performance in accounting courses, faculty recommendations, demonstrated leadership in College related activities and the potential for success following completion of the degree. Preference should be given to applicants who are available to intern with Doeren Mayhew and willing to consider full time employment with Doeren Mayhew upon graduation.
☐ <b>Michael F. &amp; Mary F. O'Donnell Endowed Scholarship</b> — Student must be a junior or senior majoring in Accounting. Must have completed a minimum of 60 credit hours with preference to a student demonstrating financial need. Minimum GPA of 3.00.
□ <b>Leonard E. Plachta Accounting Scholarship</b> – Student shall be a junior, senior, or master's degree candidate majoring in Accounting. Minimum GPA of 3.00 overall and 3.20 in accounting courses. Preference will be given to candidates who aspire to receive a Ph.D. in accounting and plan to teach at a collegiate level.
□ <b>Plante &amp; Moran Scholarship</b> – Undergraduate, major in Accounting with a minimum GPA of 3.25. Need-based scholarship.
□ <b>PricewaterhouseCoopers Accounting Undergrad Scholarship</b> − The recipient must be enrolled in the CBA with a major in accounting or accounting information systems. Student must have a minimum 3.5 overall GPA, in particular their accounting coursework. Selection will be based upon overall GPA, performance in accounting courses, faculty recommendations, demonstrated leadership in their College related activities and the potential for success following completion of the degree. Preference should be given to applicants that are available to intern with PricewaterhouseCoopers and willing to consider full time employment with PricewaterhouseCoopers upon graduation.
□ <b>PricewaterhouseCoopers MBA Award</b> – Student applying for the MBA program with an emphasis in Accounting, with a minimum GPA of 3.5. GPA requirements may be relaxed if the student has completed an internship or is involved in the Honors Program. Significant consideration will be given to activities that demonstrate leadership and the ability to effectively manage multiple responsibilities.
□ <b>Reed Family Endowed Scholarship</b> – Junior or senior with a 3.5 GPA. This scholarship will alternate yearly between an Accounting Major and a Marketing

Major. (Marketing majors are in the odd numbered years; 2013, 2015).

□ <b>B. Riley Advisory Services/Rodney L. Crawford Scholarship in Forensic Accounting</b> − 3.7 GPA Overall, and 3.7 GPA Accounting, junior or senior, with expressed interest in a career of public accounting and/or forensic accounting and be pursuing the State of Michigan's requirements for taking the CPA examination.
☐ <b>James &amp; Ann Rosloniec Endowed Scholarship</b> — Student must be at least a junior, majoring in Accounting. Preference given to transfer student from Kent, Muskegon, or Ottawa County that has completed a minimum of 60 credit hours and demonstrates financial need. Minimum GPA of 3.50.
□ <b>Paul S. Spece Award</b> – Student must be a junior or senior, majoring in Accounting or Accounting Information Systems, who has a record of academic excellence.
