- Nancy Heller Bender When the Going Gets Tough Scholarship** – Student must be a junior or senior enrolled in the College of Business Administration, with a minimum GPA of 3.30. Preference for a Michigan resident from a rural community as described by the U.S. Census Bureau. ***Must have filed FAFSA to determine financial need.***
  - Jack & Nancy Benedict Endowed Award** – Student must have a major in either business or journalism with a GPA of 2.50. The award alternates between the College of Business Administration (CBA) and the College of Arts and Media (CAM). The CBA is scheduled to award this scholarship on the odd years. The first award will be given for the fall of 2011 by CBA.
  - Bergeron Scholarship** – Student must be enrolled in the College of Business, with a minimum GPA of 3.00, majoring in marketing, hospitality, and logistics or entrepreneurship. Preference is given to those who are active participants in a student group within the College of Business Administration.
  - Ande Bodary, Jr. Scholarship** – Student must be enrolled in the College of Business Administration. Preference will be given to students from northern Michigan, which is defined as students residing in or north of Bay, Midland, Isabella, Mecosta, Newaygo, and Oceana Counties. ***Must have filed FAFSA to determine financial need.***
  - Bohl Family Scholarship** – Student must be enrolled in the College of Business Administration. ***Must have filed FAFSA to determine financial need.***
  - Bryant-Brummell Business Award** – Student enrolled in the College of Business Administration who has an interest in the study of business, with a minimum GPA of 2.75. Preference will be given to a student who has demonstrated a commitment to the advancement of underrepresented minorities in the business profession.
  - Business Leadership Scholarship** – Student enrolled in the College of Business Administration. Student must demonstrate a potential for success in business. Minimum GPA of 2.50.
  - CBA Alumni Scholarship** – Student must be admitted or enrolled in remaining admission requirements for the College of Business Administration with a minimum GPA of 2.75 at the time of application.
  - Chemical Financial Scholarship** – Student from Clare or Midland County with a minimum GPA of 3.00. Second preference is a student from the State of Michigan.
  - Lucy & Edward Collins Endowed Award** – Student enrolled in the College of Business with a minimum GPA of 3.75. ***Must have filed FAFSA to determine financial need.***
  - Dan Crociata Family Scholarship** – Student must be enrolled in the College of Business Administration with a minimum GPA of 3.00 and a resident of Michigan. Preference will be given to first generation students.
  - DMF Bait Company/Dan Beaudoin Award** – Student must be enrolled in the College of Business Administration, pursuing a B.S.B.A. degree. Preference given to a student who is an active member of Phi Chi Theta. ***Second preference will be for a student with unmet financial need as determined by the filing of a FAFSA.***
  - Deloitte LLP Annual Scholarship** – Student shall be enrolled in the College of Business Administration with a major in the School of Accounting or Business Information Systems, and who has a record of academic excellence. GPA of 3.3 or higher.
  - Deluca College of Business Award** – Student shall be a junior or senior enrolled in the College of Business Administration working toward their BSBA degree with a cumulative GPA of 3.00. Preference given to a student who exhibits leadership, community service and active involvement in the CBA and has specific career goals in mind. ***Must have filed FAFSA to determine financial need.***

- **G. Roland & Olga Jones Denison Scholarship** – Junior or Senior full-time student majoring in business which is also a Michigan resident. *Must have filed FAFSA to determine financial need.*
- **Gregory & JoAnn DeWitt Endowed Award** – Sophomore or higher, business major with a GPA of 3.00 and a resident of Kent, Ottawa or Muskegon Counties. *Must have filed FAFSA to determine financial need.*
- **Lee & Lori Dow Endowed Scholarship** – Student shall be a junior majoring in business with a GPA of 3.50. *Must have filed FAFSA to determine financial need.*
- **Dow Corning Endowed Scholarship** – Student will be a junior, majoring in business. Selection will be based upon GPA, performance in business courses, demonstrated leadership in college related activities and the potential for success following completion of degree. Preference may be given to juniors and those applicants who are available to intern as students with Dow Corning and who are also willing to consider full time employment with Dow Corning upon graduation.
- **J. Dean & Betty L. Eckersley Business Administration Scholarship** – First preference to residents of Isabella County. Second preference to Michigan residents. Must be full-time, business major with minimum GPA of 3.00 for incoming freshmen and sophomores, GPA of 3.25 for juniors, GPA 3.50 for seniors. Preference shall be given to Mid-Michigan Community College transfer. *Must have filed FAFSA to determine financial need.*
- **Emerging Business Leadership Scholarship** – For an undergraduate enrolled in the College of Business Administration who has demonstrated experience in, or commitment to, working with historically underserved or underprivileged populations, or experience living or working in diverse environments. The recipient will be from a historically underrepresented community within the United States. (Essay should elaborate on how this scholarship applies to the applicant.)
- **The Gary E. Eymer Annual Award in Business** – For a student to participate in a university-approved internship. Student must have a minimum GPA of 3.00 and be majoring in either accounting or information systems. Preference will be given to students from Ogemaw County.
- **Drusilla Farwell Foundation Award** – Student must be enrolled in the CBA with a minimum GPA of 3.00.
- **Richard and Virginia Feusse Scholarship** – Student must be enrolled in the CBA with a minimum GPA of 3.50, with an interest in the study of accounting or finance. Award may be renewable for up to four years of full-time continuous enrollment providing that a 3.50 cumulative GPA is maintained. *Must have filed FAFSA to determine financial need.*
- **Cynthia Dickey Fitzgerald Award** – Student must be a sophomore or higher with a declared major in entrepreneurship with a minimum GPA of 3.00. *Must have filed FAFSA to determine financial need.*
- **Future Business Leadership Scholarship, an Allen & Nancy Vander Laan Endowed Scholarship** – Junior or Senior enrolled full-time in the College of Business Administration seeking a Bachelor of Science in Business Administration degree with a field of study of General Business Administration, General Management and/or Economics. Candidate must demonstrate an interest in owning and running his/her own business in the future. **YOUR ESSAY MUST OUTLINE YOUR PLANS TO HAVE YOUR OWN BUSINESS.** He/she must have a minimum GPA of 3.00 and have had a small business experience. Candidate should also demonstrate a history of past philanthropy, volunteerism or giving back to his/her community or faith-based organization. Preference given to West Michigan residents. Must have filed FAFSA and have been APPROVED to receive aid. *Must have filed FAFSA to determine financial need.*
- **Glenn Family Foundation Scholarship** – The recipient must be of sophomore status or above and enrolled in the College of Business Administration and pursuing a business major with a minimum GPA of 2.50. *Must have filed FAFSA to determine financial need.*
- **Michael & Glenda Glenn Sales Institute Scholarship** – The recipient will be a student enrolled in the CBA, Department of Marketing & Hospitality Services, Sales Institute as a major or minor with a minimum GPA of 3.00. Must be a sophomore or higher and a Michigan resident.
- **Harter Family Endowed Scholarship** – Student must be junior or higher enrolled in the CBA pursuing a degree in business with a minimum GPA of 3.00.

- **Julie Schultz Hislop & Tom Hislop Endowed Business Scholarship** – Student must be a sophomore or higher majoring in management with a minimum GPA of 3.25. The recipient must be a Michigan resident who demonstrates a commitment to leadership in the College of Business Administration and who demonstrates a history of volunteerism and community engagement. *Must have filed FAFSA to determine financial need.*
- **Robert E. Hutchinson Memorial Scholarship** – Student will be a junior or higher. Student will be selected based on their leadership involvement within the College of Business Administration, the University Community and within other activities that would allow leadership opportunities.
- **Independent Bank Scholarship** – Student enrolled in the College of Business Administration with a minimum GPA of 3.00. Preference given to those who reside in the following counties: Arenac, Barry, Eaton, Genesee, Huron, Ingham, Ionia, Isabella, Jackson, Kent, Lapeer, Macomb, Mecosta, Midland, Montcalm, Muskegon, Newaygo, Oakland, Ottawa, Saginaw, Sanilac, Tuscola or Wayne. *Must have filed FAFSA to determine financial need.*
- **Willie Frances and Robert James, Sr. Award** – Student must be enrolled in the College of Business Administration, with a major or minor in business and must have completed at least one semester of academic coursework. Minimum GPA of 2.50. Preference will be given to a student from historically underrepresented populations, especially those that are first generation college students and are willing to promote diversity on campus. *Must have filed FAFSA to determine financial need.*
- **J. Edward Johnson Scholarship** – For a student bearing a high scholastic average in need of financial assistance to continue higher education.
- **Kench Scholarship** – Student must be a Michigan resident in their Junior or Senior year with a minimum GPA of 2.75, majoring in one of the following areas: Management, Marketing, Human Resources or Accounting.
- **Livingston International Award** – Student must be enrolled in the College of Business Administration, with a major in logistics management and a minimum GPA of 3.00. The recipient will be selected based on community and co-curricular activities, leadership skills, and academic excellence. *Must have filed FAFSA to determine financial need.*
- **Alan W. & Janet E. Madsen Scholarship** – Student must be freshman, sophomore or junior, enrolled in the College of Business Administration. Minimum GPA of 2.80. Preference for student to be a member of Alpha Kappa Psi.
- **Eugene McKay III Business School Scholarship** – Freshman or transfer student with a minimum GPA of 3.00. *Must have filed FAFSA to determine financial need.*
- **Dorothy G. & Robert E. Monica Endowed Scholarship** – Student enrolled in the College of Business with a minimum GPA of 3.00, majoring in accounting or information systems. Recipient must be a United States Citizen, resident of Michigan. *Must have filed FAFSA to determine financial need.*
- **Marilyn and Jerry Morey Annual Award** – Student must be a business major who graduated from a high school in Michigan with a minimum GPA of 2.80.
- **Morris Family Scholarship** – Student must be enrolled in the College of Business Administration and have a GPA of 3.20. *Must have filed FAFSA to determine financial need.*
- **Thomas C. & Sara C. Ogg Endowed Scholarship** – Student must be junior or senior, enrolled in the College of Business Administration with a GPA of 2.8 or higher and reside in Kent County, Michigan. *Must have filed FAFSA to determine financial need.*
- **Phi Chi Theta Endowed Award** – Student must be a junior or senior admitted or enrolled in remaining admission requirements for the College of Business Administration B.S.B.A. with a minimum GPA of 2.50 at time of application and be a member in Phi Chi Theta.
- **David Queller '91 and Penny Queller '91, CBA Leadership Development Program Scholarship** – Student must and a signed major in the CBA, be admitted to the CBA Leadership Development Program, have a minimum GPA of 3.00, and demonstrate unmet financial need verified by the Office of Scholarships and Financial Aid. *Must have filed FAFSA to determine financial need.*

- **Lawrence Rahilly Scholarship** – Business student in their senior year, majoring in Business. Scholarship is merit-based. *Must have filed FAFSA to determine financial need.*
- **Paul & Barbara Richards Scholarship** – Student must be a junior or senior, majoring in business with a minimum GPA of 2.80. First preference will be given to those from Livingston County, Michigan. Second preference will be for those from Wayne, Oakland, Macomb, or Washtenaw. Do NOT check the box for this award if you do not live in one of the counties mentioned above. *Must have filed FAFSA to determine financial need.*
- **Dr. Yae Sock Roh Endowment Scholarship** – for a graduating senior, enrolled in the College of Business Administration, who is majoring in hospitality services administration. Minimum GPA of 3.30. Preference will be given to students from a sole-parent household. *Must have filed FAFSA to determine financial need.*
- **Judge Bill & Eileen Rush Scholarship** – Student majoring in law and interested in pursuing a career affiliated with the law. The recipient must have a record of academic excellence, minimum GPA of 3.00.
- **Scribner Family Scholarship** – Two separate scholarships are awarded; minimum GPA of 3.00 majoring in Business. Student must have attended Cadillac High School or Mount Pleasant High School. One award will be issued to a student from each school. *Must have filed FAFSA to determine financial need.*
- **Paul Smuts Scholarship** – Student must be a business major with a minimum GPA of 3.00. *Must have filed FAFSA to determine financial need.*
- **Somes Family Endowed Award in Entrepreneurship** – Student must be an entrepreneurship major with a minimum GPA of 3.00 and a Michigan resident. The award is renewable for one year; provided the student’s cumulative GPA remains at 3.00 or higher.
- **Fredric & Katherine Stolaruk Scholarship** – For an undergraduate or transfer student enrolled in the College of Business, with a minimum GPA of 3.00. *Must have filed FAFSA to determine financial need.*
- **Kevin J. Summers Scholarship** – Student must be enrolled in the CBA with a concentration in either Entrepreneurship or Marketing, with a minimum GPA of 3.00. Preference will be given to those from either Kent or Otsego County who are active in community service. *Must have filed FAFSA to determine financial need.*
- **Mark & Michelle Szymczak Endowed Scholarship** – Student must be a major in Business Information Systems or Accounting. Preference given to students who are studying SAP and have strong leadership on campus. Minimum GPA of 3.00.
- **Mike & Beth Tierney Endowed Scholarship** – Scholarship alternates between CBA and CHP. CBA awards the scholarship in the “even” years. Preference to student from Southeast Michigan. Minimum GPA of 3.00 and a demonstrated involvement in leadership activities.
- **United Apartments McGuirk Family Scholarship** – Student must be a sophomore status or above, who plans to major in one of the following areas: Finance, Real Estate Development and/or Entrepreneurship. Minimum GPA of 3.00. Preference will be given to a current or former United Apartments customer. *Must have filed FAFSA to determine financial need.*
- **Van Faussien Family Scholarship** – Student must be an undergraduate pursuing a major through the College of Business with a minimum GPA of 3.00. Preference will be given to recipients who are working while attending school. *Must have filed FAFSA to determine financial need.*
- **Velser/Prasad Scholarship** – Student must be a junior or senior with a major in International Business and a minimum GPA of 3.25.
- **Voigtman Family Endowed Scholarship** – Awarded to a business student in his or her junior year with a minimum GPA of 3.00. Student must be a Michigan resident. Preference will be given to students who have an interest in working in capital markets.
- **Kim & Mark Wagner Family Scholarship** – Awarded to a student enrolled in a qualifying major in the College of Business Administration with a minimum GPA of 3.00. *Must have filed FAFSA to determine financial need.*

- **James H. Wanty Award** – Student must be a junior or senior majoring in entrepreneurship with a minimum GPA of 3.00. *Must have filed FAFSA to determine financial need.*
