## Scholarships for Incoming Business Freshmen

## CENTRAL MICHIGAN UNIVERSITY

# This application is for students who have not yet received a degree of any sort. If you are pursuing a graduate degree, please do not complete this application.

- Arthur Andersen Endowed Fund in Accounting: (typical award of up to \$4,000 per student) Qualifying recipients will be incoming freshmen in the College of Business Administration, intending to earn an Accounting major in the School of Accounting, with a minimum GPA of 3.50 and a composite ACT of no less than 25 or an SAT of at least 1200. Students must submit an application and essay which focuses on why they are interested in pursuing a career in accounting, as well as their involvement in school and community activities. Recipients are expected to join a Registered Student Organization (RSO) in the School of Accounting and participate in a mentoring program provided by Beta Alpha Psi (BAP), an honorary financial information organization. The scholarship is renewable with the maintenance of a 3.25 overall GPA. Qualifying students may receive the award for up to eight semesters if they continue to meet the qualifications established by the fund, including full-time continuous enrollment.
- \*\*Jerry & Felicia Campbell Scholarship: (typical award of up to \$5,000 over 4 years) Student must be an incoming freshman who has taken part in the Centralis Competition and intends to pursue a degree in business with a minimum GPA of 3.70 and an ACT score of 28 or higher, (or min 1280 SAT). Finalists will participate in a phone interview in April. Student must live in the Business Residential College in Trout Hall during his/her first year at CMU. Scholarship is renewable with the maintenance of a 3.25 GPA and satisfactory academic progress.
- Rob & Liz Haar Cornerstone Endowed Scholarship: (typical award of up to \$2,500 per student) Student must be an incoming freshman who intends to pursue a degree in business with an interest in pursuing a major in information systems. Student must have a minimum GPA of 3.00. First preference will be given to graduates of Cornerstone Schools in Detroit. While this award is renewable, it is not automatic. Students must reapply for renewal. Scholarship is based on financial need.
- Fredrick & Rosemary Kreft Endowed Scholarship: (typical award of up to \$2,500 per student) Qualifying recipients will be incoming freshmen in the College of Business Administration, intending to earn an Accounting major School of Accounting, with a minimum 3.5 GPA and a composite ACT score of at least 24 or an SAT of at least 1160. First preference given to students who are residents in the following counties: Emmet, Cheboygan, Presque Isle, Charlevoix, Antrim, Otsego, Montmorency, Alpena, Leelanau, Benzie, Grand Traverse, Kalkaska, Crawford, Oscoda, Alcona, Manistee, Wexford, Missaukee, Roscommon, Ogemaw, or losco. The scholarship is renewable with the maintenance of a 3.25 overall GPA. This scholarship can be used in addition to the scholarship package of a student qualifying for a Board of Trustees Scholarship.
- □ **\*\*Kirk H. Love Scholarship:** (typical award of up to \$2,500)

Student must be an in-coming freshman majoring in Finance and/or Personal Financial Planning with a minimum GPA of 3.50. Centralis Competition and essay required. The scholarship is renewable with the maintenance of a 3.25 overall GPA.

- □ Gene & Melissa McKay Endowed Scholarship: (typical award of up to \$2,500) Student will be an incoming freshman or transfer student pursuing a degree in business with a 3.00 overall GPA. Scholarship is based on financial need.
- David W. McQuade Scholarship (typical award of up to \$5,000). Enrolled in the College of Business Administration. First preference will be for those students from the following Michigan counties: Grand Traverse, Iosco, Kalkaska, Leelanau, Manistee, Missaukee, Montmorency, Ogemaw, Oscoda, Otsego, Presque Isle, Roscommon, and Wexford Counties. Second preference will be from Southern California counties: Kern, Los Angeles, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura. If no qualified recipients are identified within the first two geographic preferences, the pool may expand to all of Michigan. Freshman recipients must have a minimum H.S. GPA of 3.00 and demonstrate financial need.
- Scribner Family Scholarship (typical award of \$5,000). Student must be enrolled in the College of Business Administration as an incoming freshman or current student with a minimum GPA of 3.00 or higher. Preference is given to students who graduated from Mount Pleasant High School or Cadillac High School. Student must demonstrate financial need. Scholarship is renewable. The amount of the award may vary and is contingent upon the availability of funds.
- □ Jerry & Glad Scoby Endowed Scholarship: (typical award of up to \$500) Student must be enrolled in the College of Business Administration. Qualified recipients will have a minimum GPA of 3.00 and demonstrate financial need. Preference will be given to students who are from Beaverton, Michigan schools. Scholarship may be renewed for up to three years. The amount of the award may vary and is contingent upon availability of funds.
- □ Kim & Mark Wagner Family Scholarship: (typical award of up to \$1,500) Student must be enrolled in a qualifying major in the College of Business Administration. Freshman recipients must have a minimum H.S. GPA of 3.50 and demonstrate financial need.

\*\*Current eligibility for the Centralis Honors Scholarship Competition requires a 3.7 GPA and a minimum 1260 SAT or ACT of 27 or higher. The above CBA scholarships can be combined with a maximum of 2 CMU merit-based scholarships per academic year.

Students who accept the Centralis Award may not be eligible to receive the Campbell or Love Scholarships.
